

Information on the protection of personal data

The Legislative Decree n. 196 of 30 June 2003 ("Privacy Code") and the new European regulation for the protection of personal data GDPR (General Data Protection Regulation) EU regulation 27 April 2016 n. 2016/679 / EU have the purpose of ensuring that the processing of your personal data is carried out in compliance with the rights, fundamental freedoms and dignity of persons, with particular reference to confidentiality and personal identity. It is therefore our duty to inform you about our privacy policy.

The information of the site <u>https://www.creoforme.it/?lang=en</u> and decide to access the website <u>https://www.creoforme.it/?lang=en</u> (the "Users" and the "Site"), owned by CreoForme, as well as to navigate within it and to use the services therein.

It should be noted that this Privacy Policy only regulates navigation on the Site and not on other websites that may be consulted by the User through the use of links on the Site itself, even where such additional websites are owned by CreoForme; in the latter case, the "privacy policy" on the different website owned by CreoForme will apply. Browsing the Site by the User implies tacit acceptance of this Privacy Policy.

DATA PROCESSING HOLDER - RESPONSIBLE AND RESPONSIBLE

1.1 CreoForme is the Data Controller in the person of its legal representative, with registered office located in Viale dell'arteigianato n.64, 37042 Caldiero, Vr with C.F. SCGSFN83M03I775J. It decides independently on the purposes and methods of processing, as well as on the security procedures to be applied to ensure the confidentiality, integrity and availability of data.

1.2 CreoForme may designate one or more subjects as data processors pursuant to and for the purposes of art. 29 of the Privacy Code. The data processors carry out their activities according to the directives given by CreoForme and under its control; CreoForme periodically checks that the Data Processors have fulfilled the tasks entrusted to them and that they continue to provide suitable guarantees in full compliance with the provisions on the protection of personal data.

PURPOSE OF PROCESSING

2.1 We inform you that the personal data you provide while browsing the website https://www.creoforme.it/?lang=en (hereinafter, also "Site"), or otherwise acquired as part of the activity we carry out, may be processed, for the purposes related to the provision of the Service itself. After registration, pursuant to the privacy law, we may send you e-mails relating to services similar to those provided and you may object to such e-mails at any time.

2.2. Personal data collected within specific areas of the "Contacts" site will be processed for the purposes indicated in the specific information provided on the occasion of data collection.

2.3. Your data will be used, if authorization is given, for sending information and commercial offers.

METHOD OF TREATMENT

The processing of data collected for each of the above purposes according to the indications of the Privacy Code, with particular regard to the minimum security measures provided (articles 33-34), and of the GDPR (article 32) is carried out using IT tools. , manual and automated with logic strictly related to the purposes indicated above and in any case in order to guarantee the security and confidentiality of the data, adopting measures to minimize the risks of data dissemination.

TYPE OF DATA PROCESSED

Navigation data

The Site offers certain services to use which the User is required to provide additional data, which can be qualified as personal data. For example, filling out a contact form, are all activities that involve the provision by the User of personal data that allow CreoForme to uniquely identify the User such as, by way of example, name, surname, telephone number, email address. It is expressly understood that the provision of such personal data is optional, but becomes mandatory in order to allow the User to access certain services of the Site. The refusal to provide data, therefore, does not entail any consequence for the User, but in the absence of the relative contribution, CreoForme will not be able to provide the User with certain services. In order to promote and improve its products, services and content, CreoForme reserves the right to aggregate personal and non-personal data. In this case, the non-personal data will be treated as personal data as long as they remain aggregated with the latter.

CATEGORIES OF SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED

The data will be processed by employees and / or collaborators of the Owners, appointed as authorized persons in charge of processing and may be disclosed to third-party companies, appointed for this purpose as data processors, which provide ancillary and instrumental services to the Owners' activities.

In no case will the data be disseminated.

REDIRECT TO EXTERNAL SITES

The Site may use the so-called social plug-in. Social plug-ins are special tools that allow you to incorporate the features of the social network directly within the Site (eg the "like" function of Facebook).

All social plug-ins on the Site are marked with the respective logo owned by the social network platform.

When you visit a page of the Site and interact with the plug-in (eg by clicking the "like" button) or decide to leave a comment, the corresponding information is transmitted from the browser directly to the social network platform (in in this case Facebook) and stored by it. For information on the purposes, type and methods of collection, processing, use and storage of personal data by the social network platform, as well as for the methods by which to exercise your rights, please consult the privacy policy of the relevant social network.

DATA STORAGE TIMES

The data collected through scripts and cookies will be kept for the period of time strictly necessary for the purpose for which they are collected. For more information, please refer to the specific areas of the site and the cookie policy.

SECURITY MEASURES

CreoForme adopts adequate security measures in order to minimize the risks of destruction or loss even accidental - of data, unauthorized access or processing that is not permitted or does not comply with the collection purposes indicated in this Privacy Policy.

CreoForme cannot, however, guarantee Users that the measures adopted for the security of the Site and the transmission of data and information on the Site limit or exclude any risk of unauthorized access or loss of data by devices pertaining to the User; Therefore, the User is advised to verify that the computer used by the same is equipped with adequate software for the protection of data transmission over the network, both inbound and outbound (such as updated antivirus systems) and that the Internet service provider has adopted suitable measures for the security of data transmission over the network (such as firewalls and spam filters).

RIGHTS OF THE INTERESTED PARTY

We remind you that, at any time, you can request not to receive communications anymore and in any case revoke any consent given and exercise the rights of access, rectification, cancellation (so-called right to be forgotten), limitation of treatment, data portability and opposition recognized respectively by articles 15-16-17-1820-21 of the GDPR.

You retain the right to obtain from the joint controllers information about the personal data concerning you, the origin of the same, the purposes and methods of treatment; also retains the right to request the updating, rectification, integration, cancellation, transformation into anonymous form or blocking of personal data, including those that do not need to be kept for the purposes for which the data have been collected and / or subsequently processed.
